How it Works

Natural salts and fatty acids derived from Rosemary extracts and oils disrupt the insect cell structure causing the insect to dehydrate and die. SNS-217C™ kills spider mite eggs by coating them with an oily shield which prevents respiration. Therefore no hatching will occur, they will just dry out.

Directions for Use: *Shake Well Before Use*
Foliar Spray - Plant Site Use For All Plants
 (Leaves "Foliage", Stems, Stalk, Fruit and around Flowers), **Coverage** = 1 gallon solution will cover approximately 550 square feet. No restricted entry interval (REI)=0.

Mix 21 ounces (Approx. 2 ¾ Cups) to 26 ounces (3 ¼ Cups) of concentrate per 1 gallon of water*. For best results use warm (70 degree) Distilled or "Chlorine Free" water. Mixed solution may be used immediately or stored for up to 2 weeks.

*Depending upon severity of infestation several applications may be required. If needed spray every 3-5 days until you have control of the problem.

Complete coverage of all plant tissue is necessary for control. Make sure to spray under the leaves where spider mites hide and lay their eggs. To reduce the chance of burning do not use under direct sunlight or grow lamps. Use on a 7-14 day schedule as preventative maintenance. May be used up to the day prior to harvest.
