How It Works
SNS 209TM's unique formula works by allowing the plant to uptake a small amount of rosemary. As the plant distributes the rosemary throughout its cell walls, a barrier is soon constructed. When an insect starts to feed on the plant it comes into contact with the rosemary and causes the pest to stop eating, move on or die.

Directions for Use: Shake Well Before Use
Soil Drench - Plant Site Use For All Plants & Turf
(Roots), **Coverage** = 1 gallon of mixed solution to 5 gallon potted plant or 115 square feet. Mix .25 fl oz (1/2 Tablespoon or 8 mL) of concentrate to 1 gallon (3.79L) of water.

Row Crops Chemigation: 2-6 quarts per acre. Mix well. Gently feed SNS-209TM solution directly onto the root area of the plants every time you water or fertilize for a minimum 5 consecutive waterings (may be added to reservoir) or until infestation reduces. Repeat after two weeks or if infestation returns. Thoroughly drench to contact as much of the root area as possible. It takes about 1-2 weeks for SNS 209TM to start working dependent on temperature and should continue to work for up to 3 weeks.

Foliar Spray - Plant Site Use For All Plants & Turf
(Leaves (Foliage), Stems, Stalk, Fruit and around Flowers), **Coverage** = 1 gallon of mixed solution will cover approximately 550 square feet, No restricted entry interval (REI)=0 days. Mix 1 fl oz (2 Tablespoon or 32 mL) of concentrate to 1 gallon (3.79L) of water. Spray every 3-4 days for 21 days. It takes about 1-2 weeks to start working and will continue to work for up to 3 weeks. Reapply every 14-28 days as needed. Mixed solution may be stored for up to two weeks or used immediately. For best results use warm (70 degree) Distilled or "Chlorine Free" Water.
