## DIRECTIONS FOR MIXING

### SHAKE WELL BEFORE MIXING

**Potted Plants:** Mix 3-8 fl oz. (6 to 16 tablespoons, 90 ml to 240 ml) of SNS DC™ to one gallon (3.79 L) of water. **Bedded Plants, Turf & Agriculture Field:** Mix 3-8 fl oz. (6 to 16

tablespoons, 90 ml to 240 ml) of SNS DC™ to one gallon (3.79 L) of water. Mix well. Mixed solution may be stored for one week or used immediately. Multiple applications may be necessary due to the severity of disease. SNS DC™ may be used as maintenance pre-emergent disease control. Allow to dry, then culture test for disease.

## DIRECTIONS FOR USE

### SHAKE WELL BEFORE USE

**Foliar Spray - Plant Site Use For All Plants & Turf** (Leaves "Foliage," Stems, Stalk, Fruit and around Flowers). **Coverage Potted Plants** = 1 gallon of mixed solution will cover approximately 550 square feet. No restricted entry interval (REI)=0 days. **Coverage Bedded & Agriculture Field Plants** = 1 gallon of mixed solution will cover approximately 500 to 900 square feet dependent on sprayer droplet size requirements.

Spraying: Spray all plant parts (leaves, stems, stalk, crowns & other) Spraying lightly on top of the soil may be helpful in reducing unwanted yeast and molds. Be careful when contacting flowers as excess moisture may have unwanted effects. Always spray in the cooler part of the day or with the grow lights off.
