HOW IT WORKS

Systemica™ is a unique all-natural and organic formula that works as a two-in-one spray and root drench solution. Use as a foliar spray for leaves and branches, or soak the soil for root drench. It contains rosemary and clove botanicals that kill and repel insects. Systemica™ works on contact while it's also absorbed into the plant's cell walls, just like water, creating complete and total protection. If an insect starts to feed on the plant, Systemica™ causes the pest to move on or die. Pest proof your lawn and garden with Systemica™.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USE

Works best with standard residential water pressure of 40-60 PSI.

Step 1: Attach the Systemica™ bottle nozzle to your garden hose and turn on water.

Step 2: Turn to FAN setting for Systemica™ product use. Turn to STREAM setting for water only.

For use on plants, spray Systemica™ thoroughly over plant foliage. To encourage plants to absorb Systemica™, spray directly onto the root area of plants. Thoroughly drench as much of the root area as possible. Repeat applications at 7-10 day intervals or if infestation returns. Systemica™ can also be used on your lawn, around the perimeter of your home, around or in infested pet areas, and around outdoor seating areas.
